Electric waste collection vehicle trial

The try-out of the RQ-E Kerb-Sort Romaquip could lead to even cleaner, greener household waste collections in the future. Transport linked to the waste, recycling and street cleansing services is by far the largest producer of emissions linked to the Council's operational activities. This vehicle could significantly reduce CO2 emissions and help achieve the Council's target of becoming net zero by 2030.

Forest of Dean District Council has announced it will again collect trees for all households when its popular garden waste service resumes on Monday 8 January, following a two-week suspension over Christmas and New Year. Trees put out by residents will go on to be composted at Rose Hill Farm in Dymock.
