
**DECLARATION**





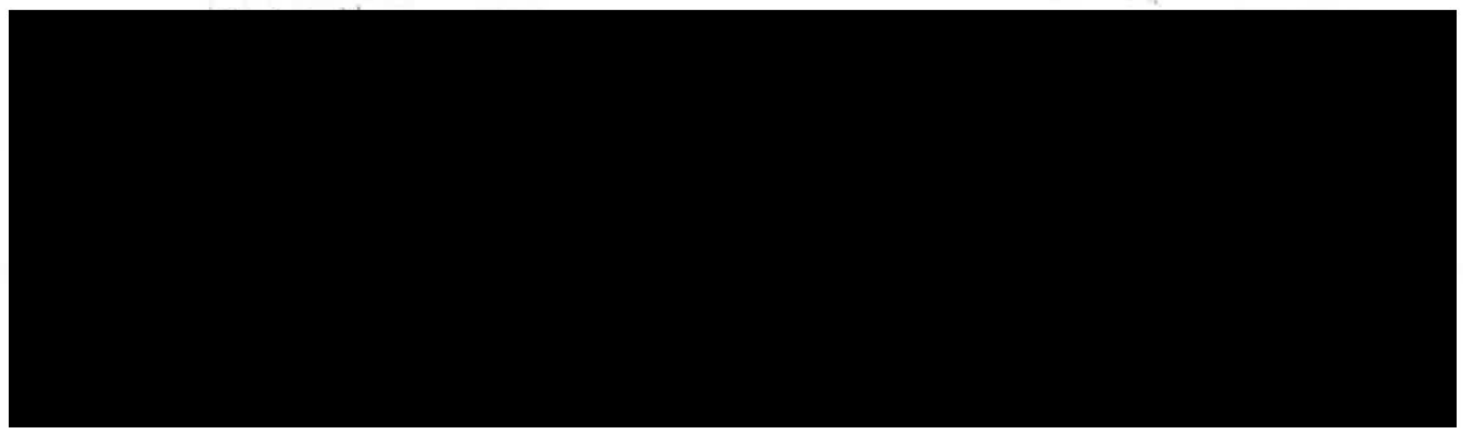
