## **Public Participation**

 Bevan Close, Soudley - Residents asked the parish council to consider taking over the responsibility for the management of the amenity area and right of way. The estate includes private ownership and social housing under the Guinness Trust Housing Association. Further information is to be sent to the council and County Cllr. Boyles will also investigate.

### RUSPIDGE WELFARE TRUST

Members' were mindful that these items were considered and determined as trustees to the RWT.

- 1. There were no Matters Arising from the Minutes.
- 2. Football Field Paul Gibson, Groundsman, advised council that there appears to be no piped drainage, or if so, it is blocked with clay. A map of the drainage was circulated, and members' **DETERMINED** that the contractor attend a site visit with Paul present. (With the drainage map Paul was later able to investigate further the relevant areas and it became apparent that there appears to be some anomalies in the work. Photographs of the areas in question have been forwarded to the contractor and a site visit requested.)
- RWT Charity Cllr. Phelps, in the absence of Cllr. Rhodes, put forward proposals including considering combining with Soudley Village Hall. Members' agreed to this in principle but further discussions will take place when Cllr. Rhodes is present.

## **FINANCIAL MATTERS**

- 1.5 Following report by the Treasurer the Council **APPROVED** the accounts presented for payment for December totalling £3,373.04 and January totalling £3,369.49, these figures being inclusive of confidential expenditure.
- 1.6 Soudley Village Hall Grant request, Bonfire Event - The council APPROVED a grant of £350.00
- 1.7 Budget & Precept 2018/19 - Members' were advised of the D Band equivalent and tax base. Council approved the budget and unanimously RESOLVED that the clerk be instructed to request £46,842.00 for the precept.
- 1.8 Office rental - Members' RESOLVED to overturn minute 9.7 of the September meeting and **AGREED** that the Parish Council will be solely responsible for the payment of office rental.
- 1.9 2018 Meeting dates - Members' determined that the parish meetings will remain the second Tuesday of each month and that there will be no meeting in August.
- 1.10 RWT Charity Scheme proposals - See RWT section above.

- 1.11 Snow clearance/grit bins - The storage boxes for bagged grit (situated in Buckshaft and Soudley) is owned by the Parish Council, the grit therein is owned by Highways. These bags are to replenish parish grit bins and are for use on roads and not private driveways. Highways have confirmed that the Parish Snow Wardens can contact the local snow plough operators directly, advising of areas to be cleared. It is hoped that the snow plough operators, whilst out clearing, will also replenish the parish grit bins in that area. Council noted that the storage bin at Soudley needs replacing.
- 1.12 <u>Viewpoint</u> - Council to investigate Mailchimp, or similar, for automatic subscription to Viewpoint.
