District Councillor Report – Richard Burton – November 2025

Council takes proactive step to secure future of Snigs End Conservation Area

The Snigs End Conservation Area, located within the parishes of Staunton and Corse, has been added to Historic England's 2025 Heritage at Risk Register - a move taken by the council as a proactive step towards protecting and enhancing the area's historic character.

The inclusion follows a detailed review commissioned by the Local Planning Authority to assess the condition of all conservation areas across the district. The review identified several issues affecting the historic character of Snigs End within its distinctive rural setting, such as the condition of buildings and the impact of gradual changes such as alterations to the original Chartist plots, unsympathetic alterations to the Chartist cottages and loss of traditional features.

Partners on board to support Forest of Dean Biosphere bid

Forest of Dean District Council continues its work with residents, businesses and partners including Gloucestershire County Council with the aim of becoming the UK's 8th designated biosphere.

A motion tabled by Cabinet Member for Climate Emergency, Cllr Chris McFarling at a recent Gloucestershire County Council meeting received overwhelming backing from members and will see the County Council provide additional funding and resources to support the Forest of Dean District Council's Biosphere bid.

It is important to note that such designation does not introduce any new legislation or statutory controls and does not have powers to remove access rights powers or stop development. This means that the historic right to Free Mine, which allows individuals certain traditional mining rights in the Forest of Dean, remains fully intact. Biosphere designation does not alter these rights, nor does it impose new restrictions on mining activities.

Forest of Dean District Council welcomes Corporate Peer Challenge Progress Review findings

Forest of Dean District Council has welcomed the findings from the Local Government Association's (LGA) Corporate Peer Challenge Progress Review, which recognised the significant progress the council has made in delivering its improvement plan and building on the recommendations made during the original 2024 Peer Challenge.

The review, carried out on 3 September 2025, found that the council had either completed or made progress on all of the actions set out in its action plan.

The LGA praised the council for its commitment to delivery, strong sense of community, and positive organisational culture, describing progress as "brilliant."

The Progress Review highlighted the council's openness, collaborative approach, and commitment to learning, noting that councillors and staff "expressed pride in their place" and were working hard to "create thriving communities for now and for future generations."

New EV car club pilot launches in Coleford

Residents of the Forest of Dean now have access to a new, flexible transport option in Coleford thanks to a 12-month electric vehicle (EV) car club pilot, led by Forest of Dean District Council.

The pilot gives residents a cost-effective, low-carbon alternative to private car ownership by making a Nissan Leaf car club vehicle available to hire via an app. Bookings can be made for as little as one hour, providing a convenient and sustainable transport solution for short trips or occasional use.

The EV will be based initially at Railway Drive Car Park in Coleford, with the pilot marking the first step towards the council's long-term vision of creating a district-wide mobility hub – including e-bike hire and expanded EV access across the district's other market towns of Cinderford, Newent and Lydney.

The scheme has been made possible through a successful £20,000 funding bid to the Western Gateway Sub-national Transport Body. The car will be operated via the Hiyacar platform, which also supports peer-to-peer car sharing.

Local Government Reorganisation

This Thursday at full Council we shall be debating the current position regarding the review. Currently the situation is

- a) a whole County unitary authority, or
- b) county split into 2...Forest, Stroud and Gloucester cityand Cheltenham, Cotswolds and Tewkesbury.

Gloucester City aks have put forward an option for a Greater Gloucester Unitary.

The outcome will be presented to Government by the end of November for a decision.

Local Plan.

Government have indicated that the Forest should accommodate a further 6000+ houses (to over 13000) by 2041.

Options are currently being looked at including 1 or 2 large settlements in the district. The Green party have indicated their preference for this but locally this is not popular. We shall be considering these and other options on Thursday.

I continue to work on ward issues and the main ones are...

Forest Lodge. The refusal for this application was overturned by the planning inspectorate and Steve Hardcastle along Leith Tony and Ray and myself have been looking at ways in which this can be questioned. It is very complex but it could be that the ombudsman may be a way forward.

I thank very much the work that Steve and Tony have put into this.

The aim of this meeting is to highlight areas in the whole district that need attention and work done to improve safety. If there is something you would like to add to this agenda do let me know.

Forest Forum: Water in Our Forest

Forest Forum: Water in Our Forest Tickets, Sun 23 Nov 2025 at 13:30 | Eventbrite (free)

How does water operate in the Forest of Dean and how organisations are working together to benefit wildlife, woodland and reduce flooding.

The Water in Our Forest forum will start with a general overview by Forestry England regarding how water operates in Our Forest, given its unique geology and geography. The effects of climate change will be considered given the likelihood of dryer summers and wetter winters in future. Water is managed in catchment areas so the Environment Agency will explain how the partnership operating in the Severn Vale Catchment will be delivering the 'Forest to Sea' project. Various organisations will describe their individual projects, to illustrate how these component parts contribute to the overall objective of managing water better in future. These will include Gloucestershire Wildlife Trust, Gloucestershire County Council (with particular reference to flood alleviation works in Lydney), Dean Heritage Centre, Severn Rivers Trust and individual projects by Forestry England.

Local Government Reorganisation Update

Future Gloucestershire: Devolution and Local Government Reorganisation in Gloucestershire.

The full LGR proposals have now been released. The proposals include one for a Single Unitary Authority covering the whole of Gloucestershire and another for Two Unitary Authorities, with one covering the West of the county (Gloucester, Forest of Dean, Stroud) and other the East (Cheltenham, Cotswold, Tewkesbury). Gloucester City Council has also developed a separate proposal for a Greater Gloucester Unitary Council.

Councillors from across the county will now discuss the proposals and vote on their preferred option. At the County level, the debate and vote is scheduled for the next Full Council meeting on the 12th November. Cabinet will then decide on the final proposal to recommend to Government, by 28 November. Government will then begin its own consultation process before taking a final decision, expected in mid-2026.

The Wye Valley Landscapes, Our Forest, talking to officers and leaders about potential budget amendments and several meetings on LGR. Very happy to give more detail on any of this if you are interested.

Cinderford & Ruspidge County Councillor Report November 2025

Cllr. Ray Donaghue.

Neighbourhood Watch Scheme – We have a meeting set at The Wesley for November 18th (Tuesday). Could everyone please let anyone who may be interest know and to contact me. All councillors are welcome. We have a FB page and I would like to encourage everyone to join it and get as much community engagement as possible.

Speedwatch – I am helping coordinate a local speedwatch campaign. Our first session is later this month.

Town Centre Regeneration – Catherine Lines (the new Market Towns Officer) has built a plan to improve the centre. I have continued arranging meetings with the different services and officers to look at how we can tidy up the highways and appearance of the town centre. This is ongoing.

We are meeting (Catherine Lines and I and I believe CTC) with a representative of the BID (Business Improvement District) and the GCC cabinet member for Business to continue the work on improving the town centre.

Fixmystreet – we now have 2 volunteers. I plan to start a FB page to highlight some of the successes and failures and get more community engagement to help improve the area's service from Highways.

There have been some enquiries for the new fund County Councillors we can access (see press release below) I am still looking for more potential projects at this stage.

Advocating for charities that are in GCC buildings at risk of closure.

Parking have been doing night visits in the town centre in order to discourage dangerous parking at our request.

I have been lobbying to get the yellow lines that need doing around the town (particularly in the triangle) ahead of schedule. It's not guaranteed but hoping to get them redone this year.

Other constituent work includes highways, planning, ASB and policing issues.

Other work I have been doing at a GCC level is:

I have started as the new shadow spokesperson for Highways.

I am arranging an in-depth scrutiny session (through the Adult Social Care Scrutiny Committee) on the local substance misuse service (called VIA) and their offer in rural areas such as ours.

There is a lot of focus on Local Government Reorganisation and we will be discussing this at the full council meeting on the 12th of November.

The grant scheme will run for 18 months, and each Councillor will have up to £20,000 to support projects in their electoral division.

SEND Survey Please Share!

If you are a parent carer of a child or young person aged between 0 to 25 years old with Special Educational Needs and/or Disabilities (SEND) who is receiving education or support in Gloucestershire, then this survey is for you.

If you know a family with SEND, please let them know about this survey, which is open until Friday 5 December 2025.

The Annual Parent Carer Survey is our way of hearing from SEND families. It is an anonymous questionnaire that asks for feedback about the education, health and care services and support available for children and young people with SEND.

We encourage SEND families to take this opportunity to share their views and experiences. It is helpful and important for us to hear about the advice, support and information they currently receive, how helpful it is, and how they think support and services can improve.

The information they share in the survey will help the SEND and Inclusion Partnership (SILAP) to better understand how to make continuous improvement to the services and offer for families.

Last year the survey was completed by 422 parent carers, predominantly from White British communities and with school-aged children between 5-16 years. The data was analysed and provided a baseline set of data for comparison. Feedback and views received have been responded to via the 'You Said, We Did' Annual Report.

Widening participation

This year we are working closely with schools, settings, community connectors, family hubs and dozens of organisations in Gloucestershire's SEND community to hear from all communities across the county. In widening participation in the survey, we are especially encouraging those families with children in Early Years and those with young people aged 16-25 to engage.

In co-production with Gloucestershire Parent Carer Forum and SENDIASS (Special Educational Needs and Disability Information, Advice and Support Service) we have applied learning from last year, so this year's survey is shorter and easier to complete. Average completion time is 12 minutes.

How do I complete the survey?

The survey is open from Monday 6 October and remains open until Friday 5 December at 5pm.
