Cost of Living Crisis

The Leader of the Council has provided the following update:

A steering group has been set up between councillors, retained officers and Publica officers focused on supporting local communities, communicating with residents and exploring additional support. Councillors' input is wanted, especially where those councillors have a link or knowledge to certain sectors or demographics within society.

A website has been set up to provide residents with advice on all the support available to them: <u>www.fdean.gov.uk/costoflivingsupport</u>. It will continue to be developed in the coming weeks including adding information on local support available in communities.

A campaign is being run across social media, the Council's e-newsletter & media focussing on financial support, community support and energy reduction. There is also an accompanying leaflet available in the Council's customer service points.

Support provided by the council

- Council tax support scheme for those struggling to pay council tax. An update to this scheme to make it available to more people has just been consulted upon and will be coming to Cabinet for a decision on 13 October.
- Housing support provides help to people struggling with accommodation including the Homelessness Prevention Grant, discretionary housing payments and advice for clients in financial difficulty.
- Supporting communities Communities Team works with local communities to help build resilience and support communities to set up support networks.
- Delivering associated support including the Holidays Activities and Food Programme, handing out government support and supporting people suffering domestic abuse.

Five Acres

A report seeking Cabinet approval to prepare for the construction stage, identify a main contractor early in the design process and provide officers with the delegated authority to proceed with the first phase of development. Possibly a Full Council decision will be needed in December 2022 to approve the budget estimate from the contractor prior to any further work commencing on site.

The project includes (with the phasing as far as I can make out)

Phase 1: the refurbishment of the existing Speedwell building to create a new community sports/leisure/education hub with ancillary car parking; a new build 4-court sports hall also suitable for use as a performance venue

Phase 2: 3G artificial sports pitch; sports pavilion; cycle hub; refurbishment of existing tennis courts; external sports equipment storage facility; car parking to include electric vehicle charge points.

- The Head of Paid Service has notified his retirement to take place at the end of March 2023. It was agreed by majority that the salary for his replacement should be increased to a maximum of £110,000. The recruitment process for a new Chief Executive to commence immediately by engaging the services of a recruitment consultancy at a cost of £25,250. The role title may be changed to Chief Executive.
- Notification of Cabinet changes Green Cabinet members Chris McFarling and Sid Phelps have been relieved of their duties.
- The proposal to increase the number of members on Planning Committee from 13 to 15 and change of the name of the Planning Committee to the 'Development Management Committee' was referred back to the Constitution Working Group due to a proposal to review whether planning committee members should be allowed to vote on planning applications in their own ward. If it is decided to change this, that would make it easier for the planning committee to be quorum and make an increase in member numbers (which was of questionable help anyway) unnecessary.
- Member Champion reports were noted and are available on the website
- The motion to pledge allegiance to His Majesty King Charles III was carried.
- The motion for the Council to do what it can to help improve the water quality in the River Wye was carried.
- The motion concerning fracking was carried. This was a reaffirmation of a previous motion with some updating and additional actions.
- The motion concerning Cannop Ponds was amended so that it read: 'To urge Forestry England to construct new dams at Cannop Ponds to retain the existing ponds and to design them to attenuate Flood Water to protect the downstream settlements of Parkend, Whitecroft & Lydney in the event of severe storms of which these settlements are in high category flood zones.' This was carried and the Head of Paid Service has written to inform Forestry England.

GCC. County Councillor's Report.

Report to Ruspidge & Soudley Parish Council – November 2022

This is my report for November, the County Council have now launched The Levelling up Together Grant Scheme, Cinderford together with other urban wards will be able to apply as they rank in the 10% most deprived wards, the total monies available is £1.5 million.

Waste Wizard has now been launched by the County Council and the District Councils, this is a new on line tool to help people across the County find out how to get rid of items sustainably.

Still with Waste you can now book a visit to your household recycling centre on the same day, the booking system that was set up during lock down, is to be retained because it helps to manage people visiting these sites with out causing traffic congestion.

The County Council has expressed an interest in the Central Government Investment Zones, in Gloucestershire they are looking at two investment zones, one would be Central Gloucestershire City Region, consisting of Golden Vally Development, Elms Park, Tewksbury Garden Town, and Gloucestershire Airport & Surrounds. The Second Investment Zone being looked at in Gloucestershire is the Berkeley Alternative Energy Park.

Back locally we have been looking at ways to solve speeding issues in Woodside Street Cinderford where four cars have been written off, the answer here is more traffic calming such as what we have in Hilldene and parts of Cinderford East.

The Safety Manager from Spelle Metcalfe that are building the New Hospital has been in touch with regard the speed of vehicles coming up Steam Road towards Cinderford, Highways have suggested they put out bigger and advanced signage to warn of a concealed entrance, Speller Metcalfe are also going to cut back the Vegetation opposite the Garage on Steam Mills Road now that the door mice are hibernating.

Another major issue is parking on Buckshaft Road, it would appear that at this point in time Gloucestershire Highways have no funded schemes outside of City areas to bring in a type of Resident Parking Scheme, they have suggested the residents contact their Housing Provider to see if they can effect some form of Off Road Parking for the residents concerned,

I am currently trying to establish if any of these Resident Parking Schemes do in fact exist in the County outside of the Urban or City Area's.

I will try and keep you updated but the best place to check is: <u>Roadworks - Highways</u> (gloucestershire.gov.uk) note: closed roads still allow access for residents.

Gigaclear is coming through Soudley between now and the beginning of January. There are estimates about which roads will be closed when on the above link. The main road from Blakeney to Ruspidge will not be closed but will have traffic lights for much of this time. Smaller roads will be closed to through traffic and may make access difficult but the work force do try to accommodate everyone's access needs.

I have had some communication about the fact that the road signs have been misleading, making it look as if the road from Littledean to Soudley is closed. I have spoken to Street Works and they have been in touch with Gigaclear who have moved signs to make the information clearer.

I have also been told by Street Works that Cindrford Road (to Blakeney) will need to be closed for Gigaclear work but that this will not happen until New Road in Blakeney is open. The latest on that is that the road is booked for closure until the 23rd December. The piling on this job took five times as long as expected causing the long over run.

Dean Road, between Littledean and Newnham will be closed for 2 weeks from the 1st December for drainage works.

I have had conversations with both Highways and PROW team about the bridge to the village hall. Highways is not responsible, and Forestry England say: I'm afraid it remains unregistered but I can recall a second bridge be put in to replace the ageing structure to the West. What I can tell you is that the Hall and associated area was sold to the Trustees of Soudley Rec Ground in 1975. You will see below that they will have at least riparian ownership of the bridging.

Highways Local money

I have had a conversation with Nathan Chout about the Highways local pot and allocated money towards one week of lengths men's work in Blakeney and Bream division which will be booked for a week in November. Please can you give me a list of any work that needs doing that is appropriate for them so that we can make sure we make the most of their time getting ready for winter. This work can include cleaning and maintaining signs, drains, gullies, hedge and verge cutting. I Would suggest that if we can make a list that can be added to at anytime and is available to Nathan then not only in this particular week but from May to October when the maintenance team are on General contract in the South Forest, we are more likely to have them do the work we would like them to do. I am happy to be the list holder, I already have a spread sheet with road issues that I work from.


Bus services

Stagecoach has given the following statement about busses in the Forest of Dean:

Changes to the Forest of Dean network from 20th November 2022:

From Sunday 20th November, we'll no longer be operating the following contracted routes: Service 25, 27, 710, 748, 755, 761.

We'll also no longer operate contracted journeys on the Service 24 between Cinderford and Chepstow. The route of the Service 24 will be adjusted to provide



connections between Gloucester, Cinderford and Coleford, replacing journeys currently operating on the Service 25.

The Robin

Driven by Gloucestershire

The Robin, an on-demand minibus service has just started operating in the South of the Forest of Dean, the A40 to the north and Chepstow to the South being the boundaries of its operation.

The Robin can be booked over the phone, on line or you can download the app from the play store. It can be booked up to 2 weeks in advance or an hour in in advance. The idea is that it will supplement stagecoach bus services especially in villages with no bus service. It will not take you to Gloucester but it will take you to the A48 or Littledean to catch a bus to Gloucester. Lydney dial a ride won the contract. There are 2 minibuses in operation. I have used it twice and it has been very efficient, an excellent service.
