- 3.8. **Financial Matters** Following a report by the Treasurer the council **APPROVED** the accounts presented for the **March** payment totalling **£8,409.18** this figure is inclusive of confidential expenditure.
- 3.9. **Soudley Village Post Box –** The members present voted unanimously in support of having a new post box sited near to the community notice board along Top Road.
- 3.10. **Soudley Village Hall CCTV** The members present contested any necessity to vote on this issue, stating, this request is outside of the Parish Council's remit, the Parish Council has **NO** authority to comment on this issue and therefore cannot approve, or disapprove of Soudley Village Hall's committee deciding to install CCTV cameras. The decision is for Soudley Village Hall's committee to decide.
- 3.11. **Clarke Telecom Tower** The members present voted unanimously in favour to the proposal from Clarke Telecom for the siting of a telecom tower in Soudley, at the Beeches, near to Hillside house. This under the proviso, the majority of Soudley's residents are also in favour of the current Clarke Telecom proposal.
- 3.12. Litter Picking Hub The Chairman deferred this subject for discussion at April's Parish Council meeting.
- 3.13. Recreational Area Annual Reports – The members present acknowledged they had received and reviewed the Annual Inspection reports from the 23^{rd of} February 2024 for Ruspidge recreation play area, the MUGA at Ruspidge recreation ground, Soudley recreation ground play area, Soudley Basketball area and Woodland View play area. Also, the members present acknowledged receipt and review of the February Operational reports for the aforementioned areas. To note, the Operational reports were performed and sent in error by KOMPAN as they are not required in the same month as the Annual reports. KOMPAN has confirmed no charge will be made for these Operational reports. Concern was raised regarding discrepancy between the Operational and Annual reports, the Clerk, Mr Roland Dowding will query this discrepancy with KOMPAN and report back to Council. It was agreed the Clerk will continue to review the quarterly inspection reports, consult and liaise with the PC's appointed contractors in regard to said reports and organise any routine maintenance required. Council members will also review the Quarterly and Annual inspection reports and raise any concerns they might have regarding the findings of the reports directly with the Clerk. Any major concerns and maintenance costs over £500.00 will be brought to the attention of full Council for debate.
- 3.14. **Ruspidge Multi Use Games Area (MUGA)** The members present approved the highlighted repairs for the MUGA as informed in the KOMPAN Annual report and after being advised by Cllr. Tony Matthews who had recently performed his own inspection of the MUGA are

confident once repairs are attended to, the MUGA will continue to be of service to the youth of the parish for the next 5 - 10 years.

Cabinet Members agree on amended budget proposals

Following consultation with residents, Forest of Dean District Council Cabinet Members have agreed on an amended draft budget for 2024/25. The proposed budget maintains local services in the face of reducing funding and plans for further expected cuts to local government finance.

Forest of Dean District Council is supporting partners Gloucestershire Domestic Abuse Support Service (GDASS) and Gloucestershire College to provide hairdressers, barbers and beauty therapists with training to respond and support clients who disclose that they are victims of domestic abuse.

Council Tax reduction for care leavers increased to include 25-year-olds

The Forest of Dean District Council will increase the age limit of its council tax reduction for care leavers from twenty-one to twenty-five years-old and make care leavers from outside the district eligible for the reduction.

Station Terrace from Beechdean through to Station Street.

Beechdean from Station Terrace through to Cedardean.

Parragate from Station Terrace Through to Cedardean.

We have also raised the issue with the Police at the Forest of Dean Road Safety Group, with regard the growing practice of parking vehicles on pavements.
