Support for the clinically extremely vulnerable

People who have been identified as being clinically extremely vulnerable will be receiving a letter from the government. Those who do not receive a letter and think they have a medical condition that places them at high risk can register on the government website for coronavirus support as an extremely vulnerable person. This support can be in the form of getting food, basic needs and prescriptions delivered.

Tier 2 COVID-19 restrictions

In summary, the new restrictions are;

- Shops, gyms and personal care services can reopen
- Collective worship, weddings and outdoor sports can resume
- You can meet people in public places but you must stick to the rule of six
- Pubs can only open if they serve substantial meals. Alcohol can be served with that meal
- Spectators can attend organised sports events with 50% of capacity or 2,000 spectators, whichever is smaller
- Non-essential foreign travel is allowed, subject to quarantine rules
- Meeting inside will still not be allowed under any circumstances, other than for those in a support bubble

There is time limit attached to these restriction. The Government has announced that, from 16th December, they will be reviewed fortnightly. Where appropriate, areas may go down (or up!) the Tiers. For full detail, see this link;

We are asking for your views on the Preferred Option during the extended consultation period between Thursday 22 October 2020 and Friday 29 January 2021

Anyone can comment to help shape the Local Plan. Comments are especially welcome which:

- ☐ Support or seek to modify the strategy
- ☐ Propose alternative sites for major or minor development
- □ Suggest any changes to the strategy showing how the plan's needs can be met in another way
- □ Provide more information about sites which the council is already aware of (such as through the SHLAA process)

The final decision will not be made until the plan is examined by an independent Inspector, and in the meantime there will be at least two further opportunities to engage with the Council about how it should be framed. These are in addition to this Preferred Option consultation.

Forest of Dean District Local Plan 2021-2041 Preferred Option

Comment by Nicky Packer, District Councillor Newnham ward

Thousands of sites for new houses must be found

The District Council need to update their Local Plan every few years, to accommodate the sites that the Government say must be found for thousands of new dwellings.

The Local Plan is important – if a site is allocated for development in the Local Plan then it becomes almost impossible to oppose that development later on. It is Central Government that **dictate how many new dwellings the Local Plan must accommodate**, not the District Council. The work done by the Council shows that it is going to be tough to find enough sites for all the houses required.

A shortfall in housing sites is serious, because then the plan won't be accepted by a Government inspector. This would lead to a 'free-for-all", with developers being able to build wherever they like. Because many of the sites already allocated for development have not yet been built out, (particularly brownfield sites), it gives the illusion that these are available for allocation, whereas the new dwellings quota is actually in addition to these already allocated sites, which are presently lying dormant.

A recent planning appeal found in favour of allowing 50 new dwellings to be built on open countryside close to Newent, because the Government Inspector decided that the Council hasn't 'delivered' sufficient new dwellings. By this he meant that not enough of the sites that have been given planning permission have been built out. Even though it is not in the Council's control to make developers start building on the land that they own and that has planning permission in place, the Government Inspector finds in favour of the developer.

The public consultation on this stage of the local plan closes on **Friday 29**th **January 2021**. See the Council website or phone the Council if you want to participate.
