# Ruspidge Memorial Hall

Since my last article, work has progressed well within the hall. The new kitchen is now finished!

We now have the following:

- An electric hob with extractor overhead
- A multifunctional eye level oven
- Catering grade worktops and splash backs
- A full size fridge and a Microwave





- A wall mounted boiling water dispenser
- An enlarged hatchway into the hall
- A cosy radiator fed from the central heating
- Lots of storage space for our regular users

# It is a lovely airy space to compliment the hall.

We have screened off an area to store all the tables and chairs when activities do not require furniture, such as an exercise class. This is also handy as it means any unused furniture can be stowed away safely when only some of the furniture is required.

The lower hall is in the process of being fitted with new flooring.

This hall has proved to be very handy as it opens out to a west facing patio and grassed



area overlooking part of the park and edged by trees. During these unusual times this has been used many times for plant sales and various meetings.

The hire charge currently for main hall costs £10.00 (£8.00 for regular bookings) per hour and the lower smaller hall £5.00

To allow for social distancing the larger hall is limited to 22 people, the lower hall 14 people. Please note however, COVID-19 restrictions below.

#### **Parish Council News**

**Audit 2019/20** – the external auditor PKF Littlejohn LLP having completed the review of the Annual Governance and Accountability Return advised 'on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met. The AGAR and Notice of conclusion of audit have been published on the council website.

Parish Council Meetings – having held two remote meetings the council were pleased to hold a face to face meeting in September. The Soudley Hall was unavailable and the meeting was transferred to Ruspidge Hall, where sanitisation was supplied and social distancing was observed. Face masks were worn at the individual's discretion and paper circulation was kept to a minimum. To keep to the meeting rota the October meeting will also be held in the Ruspidge Hall. Please note that, as a result of the COVID 'Rule of Six', members of the public will not be permitted to attend Council meetings until further notice.

**VAS – Vehicle Activated Signs** – The Council have agreed with SWARCO to renew the maintenance contract for one year.

**Football Field** – The field has been in use again, this time by a youth team. The organisers have been asked to observe the need to keep the adjacent lane clear to enable residents to access and egress safely, as vision onto Ruspidge Road is very limited.

**Dog fouling** – The Council has received complaints regarding dog fouling on the Ruspidge Play Area. This is particularly dangerous in an area mainly frequented by **children**. If the situation continues the Council will be forced to reconsider banning dogs from the field. There is no excuse as there are two litter bins, which can now be used for dog waste, and a proper dog waste bin inside the double gate entrance of the field. **Please control your dogs and dispose of their mess responsibly! Thank You.**

# Major planning shake-up proposed



## 'Planning for the Future' - White Paper & Consultation

The Government are proposing fundamental change to the planning system in England, to make development easier and quicker. They claim that this will lead to more new homes being built. However, critics of the proposals dispute that planning has significantly restricted house building, as 9 out of 10 applications are currently approved by Councils. Developers are often slow to bring forward sites for construction after obtaining planning permission, with more than a million homes given planning approval over the last decade yet to be built.

My own view is that the White Paper is a developer's dream. Here are some of the reasons why:

We may treasure the right to have some say about what happens on our locality but to developers that is just a hassle. The certainty that the Government is promising developers in the White Paper would be achieved by restricting public consultation to the drafting of the Local Plan and by stripping away all the later checks and balances that currently take place. People will wake up to find that development is proposed on their doorstep and that their right to consultation has expired, perhaps years before.

The current situation, where assessments and reports are often required to prove that a site is suitable for development, would be swept away. There would be a single test, (about which there is currently no detail), to determine whether a site should be included in the local plan. Any further assessments at a later stage, when a developer submits detailed plans for a site, are deemed unnecessary.

Proposals that comply with set standards will have permission in principle, described as 'implementing fast-track beauty'. To formulate these standards, it is proposed to set up a new national expert body and for each local authority to have a new 'chief officer for design and place-making'.

There will be little planning process other than the Local Plan. To quote the White Paper: 'it will strip away the decision-making role of the planning committee and the discretionary judgment of the planning officer'. So, under the proposed arrangements, the public will have no opportunity to influence decisions on individual developments. An application that complies with the Local Plan and with adopted standards will automatically be approved.
