



**TEMPORARY CLOSURE OF VARIOUS FOOTPATHS FOR
WYEDEAN STAGES MOTOR RALLY 2022
(CINDERFORD TOWN AND VARIOUS PARISHES) FOREST OF DEAN DISTRICT**

NOTICE is hereby given that Gloucestershire County Council intend to make an Order to close temporarily under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984 (as amended) part of the footpaths as described in the schedule below.

Schedule

Temp Closure of Public Footpaths RWD/31, RWD/45 & RWD/48, West Dean
Public Footpath RWD/45 in Speech House, West Dean from its junction with the B4226 at OSGR SO 6223/1228 (Point A on the Order Plan 1) and running in a generally south easterly direction for approximately 1.2 kilometres to its junction with DRP/25 at OSGR SO 6262/1149 (Point B) and shown by a solid black line on the order plan 1.

Public Footpath RWD/48 in Speech House, West Dean from its junction with the Class 3 road C18 at OSGR SO 6206/1188 (Point C on the Order Plan 1) and running in a generally south easterly direction for approximately 160 metres to its junction with RWD/45 at OSGR SO 6221/1183 (Point D) and shown by a solid black line on the order plan 1.

Public Footpath RWD/31, West Dean from its junction with Public Footpath DRP/30 at OSGR 6340/1020 (Point J on the Order Plan 1) and running in a generally southerly direction for approximately 1.1 kilometres to its junction with the Class 3 road C18 at OSGR 6286/0925 (Point K) and shown by a solid black line on the order plan 1.

**Temp Closure of Public Footpaths DRP/23, DRP/24, DRP/25 & DRP/30
Ruspidge**

Public Footpath DRP/23 in Ruspidge from its junction with the B4226 at OSGR SO 6424/1254 (Point E on the Order Plan 1) and running in a generally south westerly direction for approximately 2.4 kilometres to its junction with DRP/25 at OSGR SO 6311/1110 (Point F) and shown by a solid black line on the order plan 1.

Public Footpath DRP/25 in Ruspidge from its junction with RWD/45 at OSGR SO 6262/1149 (Point B on the Order Plan 1) and running in a generally south easterly direction for approximately 1.37 kilometres to its junction with DRP/24 at OSGR SO 6369/1063 (Point G) and shown by a solid black line on the order plan 1.

Public Footpath DRP/24 in Ruspidge from its junction with DRP/25 at OSGR 6369/1063 (Point G on the Order Plan 1) and running in a generally south easterly direction for approximately 2.4 kilometres to its junction with the Class 4 road 403008 near Upper Soudley at OSGR SO 6571/0982 (Point H) and shown by a solid black line on the order plan 1.

Public Footpath DRP/30 in Ruspidge from its junction with DRP/24 and DRP/25 at OSGR 6369/1063 (Point G on the Order Plan 1) and running in a generally south westerly direction for approximately 540 metres to its junction with RWD/31 at OSGR 6340/1020 (Point J) and shown by a solid black line on the order plan 1.

Temp Closure of Public Footpaths ENE/30 & ENE/31, Lower Soudley

Public Footpath ENE/30 near Lower Soudley, from its junction with the Forest track at OSGR SO 6684/1032 (Point A on the Order Plan 2) and running in a southerly direction for approximately 590 metres to its junction with ENE/31 at OSGR SO 6685/0974 (Point B) and shown by a solid black line on the order plan 2.

Public Footpath ENE/31 near Lower Soudley, from its junction with ENE/30 at OSGR SO 6685/0974 (Point B on the Order Plan 2) and running in a generally north westerly direction for approximately 500 metres to its junction with Public Bridleway ENE/32 at OSGR SO 6657/1007 (Point C) and shown by a solid black line on the order plan 2.

Temp Closure of Public Footpath DCF/10, Cinderford

Public Footpath DCF/10 near Cinderford, from its junction with the A4151 at Steam Mills at OSGR SO 6452/1602 (Point A on the Order Plan 3) and running in a generally south westerly direction for approximately 5.0 kilometres to the Speech House Forestry Car Park at OSGR SO 6242/1249 (Point B) and shown by a solid black line on the order plan 3.

The closures are necessary for the Wyedean Stages Motor Rally 2022.

The Order will come into force on the 15th October 2022 and the public right of way will close on that day only. This Order authorises the closure for up to six months but if the closure is still required it will be necessary to apply to the Secretary of State for an extension of time

Alternative route: as signed on site

Emergency and pedestrian access to adjoining premises will be maintained.
